Sub : Police Estt - Revision of probation date in the cadre of CPO by treating the training period as duty -orders issued reg

As per the Government order cited 1st, which is a clarification to section 88 (2) of the Kerala Police Act 2011 which has effect from 31.01.2011( the date of notification of Police Act) , the period of training including examination and extended period of training, if any, shall be treated as officiating service for the purpose of probation, increment and pension, on completion of training. During the training prescribed under section 88(2) of the Kerala Police Act 2011, the trainees are entitled to stipend equal to the minimum of the basic pay of the post to which they are selected. The government, vide letter cited 2nd , have also clarified that the provisions contained in the G.O cited has to be implemented with effect from 31.01.2011.

In the reference read as 3rd cited, SPC has instructed to take necessary action to implement the G.O cited 1st , in the case of those who are appointed after 31.01.2011 and to revise the service benefits already given.

Accordingly the declaration of probation in respect of the following Civil Police Officers are hereby revised by treating the training period as duty and declared to have completed their probation in the cadre of Civil Police Officer satisfactorily with effect from the date noted against each their names in column No.10
