Sub : Police Estt - Appointment of Sub Inspectors of Police in KCP Cadre -Provisional appointment - Regularized - Orders issued.

The following 52 candidates were advised by Kerala PSC for appointment to the post of Sub Inspector of Police (Trainee) in Kerala Civil Police cadre, vide the advice letters 2nd cited. After completion of all procedures, they were provisionally appointed as Sub Inspector of Police (Trainee), under clause (1) of Sub Rule (a) of Rule 9 of General Rules and as provided in Rule 10 (b) of those Rules vide GO (P) No. 49/74/PD dated 05.03.1974, subject to the verification of their character and antecedents. Subsequently, they were admitted to undergo basic training at Kerala Police Academy, Thrissur. After the completion of Basic and Practical Training, they were posted to various Ranges as Sub Inspectors of Police and they are continuing in the post of Sub Inspectors of Police in KCP Subordinate Service.

As per the Government Order 1st cited, all PSC appointments are to be regularized after getting verification report from KPSC, in addition to Police Verification Report. The Police Verification has been conducted before the issuance of Appointment Order to the following Sub Inspectors of Police. The regularization of their provisional appointment were kept pending due to the non completion of PSC verification. Now, the Kerala Public Service Commission have completed verification issued Verification Certificates, vide reference 3rd cited, in which "it is certified that the identity of the said Sub Inspectors of Police are verified with the records and found correct and if otherwise eligible, their appointment shall be regularized".

In the light of the Verification Certificates received from the Secretary, Kerala PSC, Thiruvananthapuram, vide reference 3rd cited, the provisional appointment of the following 52 Sub Inspectors, who were advised by Kerala PSC vide reference 2nd cited and appointed in Police Department as Sub Inspectors of Police in KCP Cadre, is hereby regularized with effect from the dates mentioned in Column No.07 on which they were admitted for basic training at Kerala Police Academy, Thrissur.

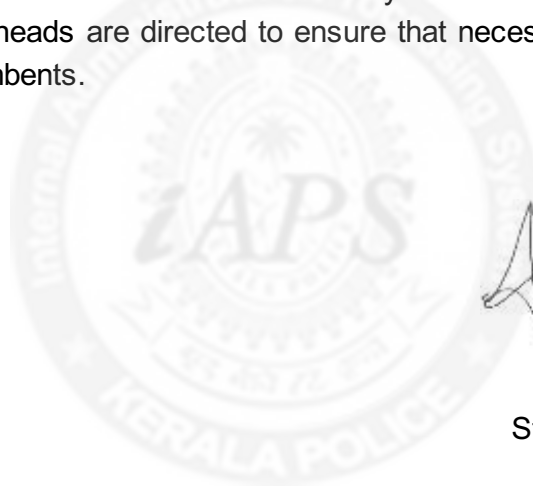
